Rules & Regulations

- Please review General Rules for Exhibitors. Superintendent contact information is listed there.
- **Entry forms & fees due by 7/25 (postmarked).**
- Please mail entry forms & fees to 20 Office Park Way, Suite 131, Pittsford, NY 14534. Make checks out to the Monroe County Fair & Recreation Association.
- Entry fee is \$1.00 per item for Adult exhibitors. No entry fee for Youth or Child exhibitors.
- Late entries subject to a late fee of \$10 per exhibitor.
- **Drop-off entries** must be brought to the new fairgrounds at 6565 East River Rd, Rush, NY 14543 on **Monday, July 29th, from 9am to 12pm** or by appointment with the superintendent.
- **Mail-in entries** must be *received* by 7/29. Include entry form and payment with items being entered. To have articles mailed back after the fair, include return postage & packaging.
- Exhibits must have an index card attached with details such as fabric content, pattern name/number, technique(s) used, care instructions, etc. as appropriate.
- Exhibitors may enter as many classes as desired. Only two entries per class.
- Please review all sections & classes before classifying entries to ensure correct choice.
- All entries must be made by the entrant and completed in the last two years.
- Entries must not have been previously entered in the Monroe County Fair.
- Entries are judged on artistic quality, craftsmanship, general appearance & originality.
- Judging will take place the week of the fair, date to be announced. Judging is not open to the public.
- Judges reserve the right to determine eligibility of entries and to reclassify entries.
- Decision of the judge is final.
- Care and security for exhibits will be provided, but the fair assumes no responsibility for loss or damage to exhibits from any cause.
- Competition is open to all.
- Entries can be picked up on Sunday, 8/4, at 5pm or Monday, 8/5, by appointment.

- Index card label should include name or source of pattern, fiber content, and care information.
- All items must be on hangers, clean and pressed.

SECTION C – Sewing Heirloom Techniques

- An item that is entered into this section should contain one or more of the following techniques: pin tucks, lace shaping, Madeira appliqué, puffing, smocking, lace-shaped insertion, sharks teeth, hem-stitching (wing needle), drawn thread work, silk ribbon embroidery, cut work, shadow diamonds or shadow work embroidery.

 - Quilts must be 3 layers & are grouped by construction technique. Quilts of any size may compete in any class. Quilted garments are included. Please note pattern name or quilt title on entry form.

SECTION M – Hand Spun Yarn

- Index card label must include a plan for usage. Skeins should be approximately 2 ounces in weight (1.5 ounces for specialty yarns – silk, angora, cashmere, etc.).
1. Proficiency of spin: 2 skeins of 2-ply yarn which will be judged on evenness of spin and evenness of ply color

SECTION N – Lace

1. Bobbin Lace
2. Tatting

SECTION O – Weaving (Loom Woven)

1. Garment
2. Rug or Wall Hanging (ready for hanging)
3. Coverlet, Blanket or Lap Robe
4. Any Wearable Accessory (purse, scarf, jewelry, hat, etc.)
5. Any Other Non-wearable Accessory (pillow, table linen, etc.)

SECTION P – Basketry

1. Original Designed Basket

SECTION Q – Wearable Art

1. Decorated Sweatshirt, T-shirt or Blouse
